

**ON-LOT SEWAGE DISPOSAL SYSTEM
“SEASONAL CABIN / MANUFACTURED (MOBILE) HOME AFFIDAVIT”**

This form may be used to satisfy one of the conditions for extending the requirement to have the on-lot sewage disposal system pumped and inspected in accordance with the OLSDS Pumping and Inspection schedule listed under Chapter 18 Section 115(2) and further described in Chapter 18 Section 115(4) which allows treatment tanks to be pumped out at less frequent intervals when the owner demonstrates such property is not occupied on a full-time basis.

This extension applies only to those river Island Properties as listed herein located in District A.

The current pumping schedule for District A begins June 1, 2021 thru June 30, 2022 (Cycle 2) and is hereby extended to begin June 1, 2025 thru June 30, 2026 (Cycle 3) pending submission of this Seasonal Exemption Affidavit.

This form must be filled out completely and submitted to Londonderry Township on or before **June 30, 2022** to be valid. Seasonal Exemption Affidavits will not be accepted after June 30, 2022.

PROPERTY USE:

I hereby certify that the cabin / manufactured (mobile) home identified herein is used as follows:

EXEMPTION PERIOD:

This seasonal exemption is valid for the four (4) year period beginning June 1, 2021 thru June 1, 2025.

This seasonal exemption expires effective May 30, 2025.

This seasonal exemption becomes null and void upon change of ownership.
